#### AGENCIES New Delhi

Indian boxers will know their global standing from their Asian Games show, High Performance Director Santiago Nieva said today and reckoned the draw could play a crucial role in how well the pugilists perform in Jakarta. Seven men and three women pugilists were given an official send-off by the Boxing Federation of India (BFI) and Sports India ahead of their flight for Jakarta Wednesday.

"Now we will know how good we are. This will be the test and we will know where we stand because some really strong countries will be there." Nieva The boxers had said. accounted for five medals — one gold and four bronze — in the 2014 edition in Incheon, South Korea. This was way lower than their best ever per-



formance which came in 2010, when the boxers bagged 2 gold, 3 silver and 4 bronze medals in all. "The draw is going to be big and it will be certainly a factor. But we have grown enough to ensure that it is not as big a factor. But this is not going to be that easy," he said.


