12 dead as vehicles collide in Jodhpur

JODHPUR: Twelve people, including two children, died when two vehicles collided head-on in Rajasthan's Jodhpur district, police said on Tuesday. The incident occurred near Agolai village in Balesar area, 73 km west of Jodhpur city, on Monday night. The collision was so intense that the heads of two passengers were severed and some of them got badly stuck in the mangled vehicles, an officer said. Ten people died on the spot, while two succumbed to injuries in a hospital.

15 security personnel injured in Jharkhand IED blast

RANCHI: At least 15 security personnel were injured when Maoists detonated an improvised explosive device (IED) in Jharkhand on Tuesday, police said. The IED hit a vehicle of the security personnel while they were on patrol duty in the forest area of Rai Sindri hill in Seraikela district. After the blast, Maoist guerrillas started firing at the security forces. The injured personnel were airlifted to Ranchi for treatment. "The IED had been planted to influence the recently concluded Lok Sabha elections. The security personnel were returning after patrolling when the blast took place," Jharkhand Director General of Police D.K. Pandey told the media.

Harsimrat wants Modi to take up Guru Nanak palace demolition issue with Pak

CHANDIGARH: Shiromani Akali Dal MP from Bathinda, Harsimrat Kaur Badal on Tuesday urged Prime Minister Narendra Modi to strongly take up with his Pakistan counterpart Imran Khan the issue of partial demolition of Guru Nanak Palace in Pakistan's Punjab province. "I join the #Sikh community in condemning the demolition of historical #GuruNanakPalace in #Pakistan's #Punjab province by some vandals in connivance with Auqaf authorities. As #Sikhs are deeply anguished, I urge @narendramodi ji to strongly take it up with Pak PM @ImranKhanPTI (Pakistan Tehreek-e-Insaf)," she tweeted.

Teacher awarded life term for sodomising over 25 boys

Jaipur: A court here on Tuesday awarded life imprisonment to a tutor for sodomising over 25 minor boy students over a period of six years. Ramiz Raja was convicted under sections of the Protection of Children from Sexual Offences (POCSO) Act, the Indian Penal Code and the Information Technology Act by the POCSO court-3. Magistrate Rajesh Kumar awarded life imprisonment to the teacher under the POCSO act. "Raja sodomised the students who used to go to his home for tuition classes. He made video clippings of the crime and had been asking the students to bring money for him," the counsel of one of the victims, Aslam Khan, said.

Girls outshine boys in Maha HSC exams

PUNE: Girls have outperformed boys in the class 12 examination in Maharashtra, results for which were announced on Tuesday. Girls have secured a pass percentage of 90.25 per cent against 82.40 per cent of boys in the Higher Secondary Certificate (HSC) examination conducted by the Maharashtra State Board for Secondary and Higher Secondary Education (MSBSHSE) in February-March 2019. The total pass percentage stood at 85.88% this year, announced board chairperson Shakuntala Kale. A total of 1423503 students had registered for the exam of which 1421936 students appeared, and 1221159 of them passed. Among the divisions, Konkan secured the highest pass percentage at 93.23 per cent.

Armed men attack police party, free convict **CHANDIGARH:** Three motorcycle-borne men opened fire at police personnel in Karnal on Tuesday and managed to free from custody a convict they were transporting from a court, officials said. The daring daylight raid took place when the police party was transporting the convict to Yamunanagar from Karnal after a hearing. Two policemen were injured in the attack, they said. Sunil (23), alias Kheera, a resident of Panipat, is a convict in a dacoity case and was undergoing trial in five other cases of heinous crimes, an official spokesperson said here. "He was freed by three assailants, who shot and injured two police officials escorting him at New Bus Stand, Indri Road Karnal," he said.

"She will stick to her chair at all costs till people decide to remove her," he said, claiming that in the assembly polls, which are due in 2021, her party will struggle to emerge to get the status of the opposition party.

The TMC had won 211 of the assembly's 294 seats in 2016. The BJP had won only three seats, but has since emerged as the principal challenger to her. A party needs to win at least 10 per cent of seats to be officially recognised as the main opposition party. "People are fleeing the TMC to join the BJP. Many more will join in the coming weeks," Roy said. With over 50 councillors joining the BJP, the party has got a majority in at least three municipal councils. Vijaywargiya noted that Prime Minister Narendra Modi had said in a speech during his campaign that over 40 TMC MLAs are in touch with the BJP and many regional party leaders are feeling suffocated due to Banerjee's "dictatorial" functioning. "We want her government to continue till 2021, but if it falls due to her doings, then we cannot help it, he said in a swipe at her. Mukul Roy also rejected the TMC's claim that the BJP was practising horse-trading by luring its leaders. Many MLAs of other parties, including the Congress, have joined the TMC due to "horse-trading", he countered.

Mukul Roy is seen to be instrumental in engineering the defection of TMC leaders to the BJP and, political watchers believe, he is one of the key architects of the party's best ever Lok Sabha election show in the state, where Banerjee is in power since 2011. In the polls, the TMC's tally fell to 22 seats from 34, while the BJP's zoomed to 18 from two.


Naidu asks TDP cadres not to be disheartened
