Facebook India Associate General Counsel Namrata Singh and the company's Director of Public Policy Shivnath Thukral attended the meeting and discussed several issues. Google officials informed the committee that between January and March 2021, YouTube removed over 9.5 million videos for violating its community guidelines. "95 per cent of these videos were first flagged by machines rather than humans. Of those detected by machines, 27.8 per cent never received a single view, and 39 per cent received between 1 and 10 views. During this same quarter, YouTube terminated over 2.2 million channels for violating its Community Guidelines. In this same period, YouTube removed more than 1 billion comments, the majority of which were spam and were detected automatically," officials told the committee.
