CBI arrests seven in NPCC bribery case

NEW DELHI: The CBI on Monday arrested seven persons, including public servants, for allegedly demanding a bribe of Rs 25 lakh for processing and passing of bills pertaining to the contracts awarded by National Projects Construction Corporation (NPCC) Limited. Searches have also been conducted at the premises of the accused in Delhi, Silchar, Jalpaiguri, Guwahati and Gwalior which led to recovery of several incriminating documents and articles, the CBI said. All the arrested accused are being produced before competent courts day, the agency added.

Heavy rains cripple life in Uttarakhand, alert issued

DEHRA DUN: Heavy rains across Uttarakhand on Monday continued to affect normal life and led to an 'orange' alert - the second-highest category of weather warning - being issued across the hill state. The rain led to landslides at various places, including the Gangotri Highway, while two houses collapsed in Chamoli district, but no injuries were reported as luckily the houses were then empty. While the India Meteorological Department has advised people not to travel to higher reaches of the state, the State Disaster Response Force has been put on a 24-hour alert on the 'Char Dham' Highway, and 30 teams set up at 63 points. They are also coordinating with the district administration, police and the Disaster Management Control Room, so they be deployed as soon as possible in any emergency.

Minor reshuffle in Delhi Cabinet, Gahlot gets Environment

NEW DELHI: In a minor reshiffle of portfolio, Delhi Transport Minister Kailash Gahlot has been given the additional charge of Environment, Forest and Wildlife, the Delhi government said on Monday. The portfolio was earlier handled by Imran Hussain, who is also the Food and Supplies Minister. Gahlot now heads a total of six portfolios -- Administrative Reforms, Information & Technology, Law, Justice & Legislative Affairs, Transport, Revenue, and Environment, Forest and Wild Life.

Canadian national robbed in Delhi Cantt area

NEW DELHI: A Canadian national working with Indigo Airlines was manhandled and robbed of Rs I lakh by three unknown assailants, including a cab driver, in Delhi Cantonment area, police said on Monday. The incident occurred on early Saturday when the victim, later identified as Mhd Mehdu Ghanzanfani, was waiting for his company cab near Delhi Cantt metro station gate number-2, police said. "While Ghanzanfani was talking to his company cab's driver, one of the accused approached him and asked him to talk to him in Hindi. He later requested the victim to drop him by his cab by charging Rs 100 near his office cab," said Deputy Commissioner of Police Sanjay Bhatia.

BJP MLA's daughter, hubby roughed up outside courtroom by lawyers

ALLHABAD: BJP MLA Rajesh Mishra's daughter Sakshi and her husband Ajitesh Kumar, who allegedly feared for their lives for marrying outside their castes, were attacked inside the High Court complex on Monday by some lawyers, minutes after they were ordered to be given protection by the court.

The couple, who were stepping out of the courtroom after the hearing and were pushed around, were rescued by other lawyers, the Cantonment police station SHO A K Gautam told PTI.

He said the couple was not willing to lodge any complaint on the incident and that media reports of their being attacked was baseless. Justice Siddharth Verma granted protection to Sakshi and Ajitesh who had asked for security contending that there is a threat to their life from Mishra who is unhappy with the marriage as Sakshi is a Brahmin and

According to a lawyer, the court order would come into force only after the requisite signature was procured. The couple had prayed that neither police nor Mishra should disturb them in their peaceful living as they were adults and had got married on their free will. Meanwhile, another couple was allegedly abducted from outside the court premises, leading to a high drama in the area with people thinking that it was Sakshi and Ajitesh.

Later, SSP of Allahabad, Atul Sharma said the couple has been rescued from Fatehpur district and are being questioned. A senior police official S N Sawant told reporters that the information on abduction of the couple was received through a TV channel and by scanning the CCTV around they got the details of the vehicle used in the act.

Shortage of spares of AN-32 jet due to strain in Russia-Ukraine ties

NEW DELHI:•There is shortage of certain Russianorigin spare parts of AN-32 transport aircraft due to strained relations between Russia and Ukraine, the government said on Monday. In a written response to a question in the Rajya Sabha, Minister of State for Defence Shripad Naik said the Indian Air Force (IAF) has 98 AN-32 aircraft and none has outlived its operational life.

"More than half of Indian Air Force's AN-32 aircraft have been upgraded with structural upgrade as well as installation of advanced avionics such as radar, radio sets, navigation system etc and the remaining are under upgradation in a phased manner.

The serviceability of the fleet has been at par with other fleets," he said. "There is shortage of certain spares of Russian origin due to strained relations between Russia and Ukraine," Naik added. Russia had annexed Crimea from Ukraine in 2014 following which the ties between the two nations strained.

In response to another question, he said 500 terrorists were killed in counter terrorist (CT), counter infiltration (CI) and terrorist initiated incidents (TII) in 2017 and 2018.
