Can't give timeline for Masood Azhar's listing as global terrorist at EU: German envoy

NEW DELHI: Germany is "very much" pushing for the listing of Jaish-e-Mohammed chief Masood Azhar as a global terrorist at the European Union (EU), but a timeline for it cannot be given, Jasper Wieck, the Deputy Head of the German Mission in India, said on Tuesday. He said Germany is hopeful that at a certain stage, Azhar will be designated as a global terrorist at the United Nations too. "We are working on it... We still have hope that the listing will take place at the United Nations at a certain stage and that would be a better solution. "In the short-term, we are working on this within the European Union. I cannot give you an exact timeline on how it will be done, but Germany is among those who are very much pushing for this," Wieck said at a press conference.

TN CASH FOR VOTE SCAM ERUPTS

Kanimozhi raided, Vellore poll off

Barely hours after the high voltage campaign for the Parliamentary elections ended in Tamil Nadu, the President issued a notification cancelling polling in Vellore Lok Sabha constituency where DMK treasurer Durai Murugan's son Kathir Anand is contesting and over Rs 11.5 crore was seized from an associate last month. The DMK has called it a "murder of democracy" and told a TV channel that they will challenge the decision to cancel the polls. This is the first parliamentary



constituency where polling has been cancelled on charges of voter bribery. Polling is slated in Tamil Nadu on April 18. But in a more startling development, the Income Tax Department conducted late night searches at a house where the DMK leader and Thoothukudi Lok Sabha candidate Kanimozhi is staying. The late Karunanidhi's

daughter Kanimozhi is pitted against BJP state president Tamilisai Soundararajan.

It was alleged that "lots of cash" was stashed on the first floor of her house in Thoothukudi, unnamed sources were cited as saying.

The PPJ was not able to verify the claim; however, it is fact that in the run-up to the polls, in a string of raids in the state, Rs. 500 crore in illegal cash and gold has been seized.

Questioning the timing of the Income Tax department's searches, the DMK alleged that the raids were a "conspiracy" by certain po-



litical leaders who could not face them in the electoral arena. It was also claimed that nothing had been found at Kanimozhi's residence. Tamil Nadu already holds the dubious dis-

inction of election notifications being rescinded in two Assembly elections in 2016 and one by-election in April 2017.

The Rashtrapati Bhavan had received the Election Commission's recommendation to countermand elections in Vellore on Monday night and the request could not be ignored after the massive cash haul, EC sources said.

Those who don't vote at all or vote for the Congress will be identified and not given work," Katara said, as he campaigned for BJP candidate Jaswant Singh Bhabhor from Dahod.

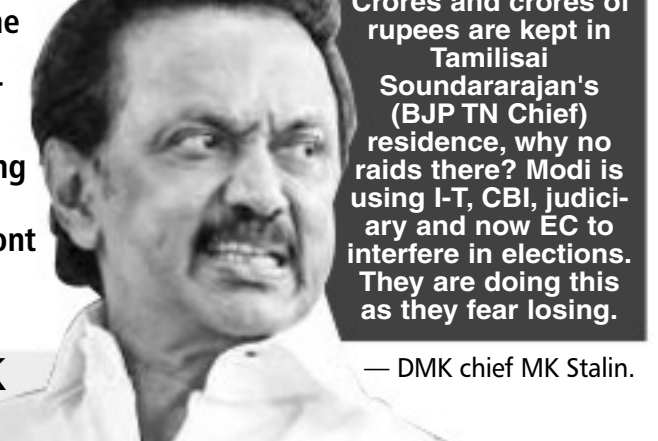

Michel wants interim bail for celebrating Easter

NEW DELHI

British national Christian Michel, the alleged middleman in the Rs 3,600-crore AugustaWestland VVIP chopper deal case, on Tuesday moved a Delhi court seeking bail to celebrate Easter. He wished to attend the holy mass on the Easter day and wanted to make offerings during those holidays.

The interim bail plea was moved before Special Judge Arvind Kumar, who has sought Enforcement Directorate (ED) and the Central Bureau of Investigation (CBI) response on Michel's application.

SC to hear I-T department plea against Chidambaram's family

The Supreme Court on Tuesday agreed to hear the Income Tax department's appeal challenging the Madras High Court order which quashed criminal prosecution against senior Congress leader P Chidambaram's family members under the black money law.

The top court, however, refused to stay the order of the high court. A bench of Chief Justice Ranjan Gogoi and Justice Sanjiv Khanna issued notice to Chidambaram's wife Nalini and their son Karti, who is contesting Lok Sabha election from Sivaganga constituen-

cy in Tamil Nadu. The bench also sought reply from Karti's wife Srinid-

hi and others in the case. The high court had quashed criminal prosecution initiated by the I-T department under the Black Money Act against the three.

Solicitor General Tushar Mehta, appearing for the I-T

department, sought stay of the high court order of November 2, 2018 on various grounds including that it can be used by other accused to avoid criminal prosecution in cases related to black money. To this, the bench said that granting stay at this stage without hearing the other side would amount to allowing the appeal of the I-T department. The Solicitor general further said that if the stay is not granted then the criminal prosecution against similarly placed accused under the black money law and urged that the November order of the high court should not be treated as a precedent.

DELHI COURT GRANTS BAIL TO GAUTAM KHAITAN

A court here on Tuesday granted bail to lawyer Gautam Khaitan in a money laundering and black money case. Special Judge Arvind Kumar allowed Khaitan's bail plea asking him to furnish a personal bond of Rs 25 lakh and two surety like amount each.

The court directed him not to influence witnesses or hamper the investigation in the case. It also directed him to join the investigation in the case whenever required. The Enforcement Directorate (ED) opposed Khaitan's bail plea.

It was the second bail plea moved by Khaitan. On March 12, the court had rejected his first plea for bail. Khaitan was arrested on January 25, a week after the Income Tax Department searched his offices and other properties in Delhi and the National Capital Region.

On March 25, the ED filed a chargesheet in the money laundering case.

With saree stuck in metro door, woman gets dragged on platform

A 40-year-old woman suffered head injuries on Tuesday after her saree got stuck in a carriage door of a Delhi Metro train as it was about to leave a station, due to which she got dragged on the platform, her husband said.

The victim, Gita, a resident of the Shashtri Nagar

area near Inderlok, was travelling with her daughter when the incident took place at the Moti Nagar metro station on the Blue Line. "Gita and my daughter were travelling from Nawa-da. They got off at the Moti Nagar station when the 'pull' of Gita's saree got stuck in the closing door. As a result, she got dragged for some distance on the plat-

form," her husband Jagdish Prasad said.

Gita, a housewife, suffered injuries on her head and was rushed to a nearby hospital, Prasad added. "I got a call from my daughter who told me about the incident. Apparently, one of the commuters had pressed the emergency button to alert the driver for stopping the train," he said.

Confirming the incident, a senior Delhi Metro Rail Corporation (DMRC) official confirmed said the incident was reported at Moti Nagar station (Line-3) at 9.19 AM where a woman passenger's saree got stuck in the train doors while de-boarding from the metro train going towards Vaishali.

"The train operator immediately applied the emer-

gency brakes and stopped the train."The station controller also rushed to the incident site where the passenger was rescued and immediately sent to a nearby hospital after providing first aid. Delhi Metro advises its commuters to be extra careful while boarding and de-boarding from metro train, especially during peak hours," DMRC stated.

Indian Navy loses helicopter in Arabian Sea

New Delhi: A major "catastrophe" was averted by a naval aircrew when their Chetak helicopter ditched at Arabian Sea last week, the Navy said on Tuesday. It said a board of inquiry has been ordered to investigate the cause of the technical failure leading to the loss of the helicopter. The helicopter was part of an Indian naval warship which was deployed in the Arabian Sea. "As per reports, the helicopter developed technical failure prior to ditching and the crew displayed immense professional prowess and sound training in deftly landing the helicopter in the water and successfully regressing from it," the Navy said.

N D Tiwari's son passes away

Rohit Shekhar Tiwari, son of the late Uttarakhnd Chief Minister N D Tiwari, died on Tuesday, police and hospital officials said. He was brought dead at Max Hospital in Saket in south Delhi, the hospital said. DCP (South) Vijay Kumar said Rohit Tiwari, a resident of Defence Colony in south Delhi, was brought to the hospital around 5pm in an ambulance, where doctors declared him dead.

His mother Ujjwala Tiwari was also admitted to the same hospital where she received a call from their home about her son being "unwell and bleeding from nose", he said. "Max Hospital received an emergency call from the residence of Rohit Shekhar Tiwari at 4:41 pm this afternoon.

Naresh Goyal opts out

Jet Airways founder Naresh Goyal has decided not to bid for a stake in the cash-strapped airline, sources said on Tuesday.

The full service carrier is awaiting fresh fund infusion under a debt resolution plan.

According to sources, it has reportedly requested lenders for an interim funding of Rs 400 crore to stave off a temporary closure, even as its current operational fleet further shrank to five aircraft. The shares of Jet Airways plummeted nearly 19 per cent on Tuesday. The Board meet on Tues-

day was inconclusive. "We are awaiting for the lenders reply. It is of paramount importance that we receive a clarity on interim funding," an airline source told IANS.

According to industry sources, Etihad and TPG Capital had indicated they would consider pulling out of the race if Goyal is allowed to submit his bid for the crisis-hit airline.

SBI Caps, the merchant banking arm of SBI, is currently shortlisting investors who are interested in a fresh infusion of funds. Last month, Goyal and his wife Anita Goyal stepped down from the board of the airline, which has more than Rs 8,000 crore debt.

India's travel spend to grow to \$136 bn by 2021

The travel spend in India is expected to grow at 13 per cent to a total of \$136 billion by 2021, said a new report by Bain & Company and Google India on Tuesday.

According to the "How Does India Travel" report, the Indian traveller spent around \$94 billion in 2018 on around 2 billion domestic and international trips, thus, helping India's travel and tourism industry achieve unprecedented scale.

"New users perceive that online channels are geared towards more frequent flyers and experience-oriented travellers and existing travellers research online but the lack of trust in payments and booking experience make them end up booking offline.

"If travel players tap these online users through personalised marketing, messaging and travel plans, they can further augment online travel bookings. This can be done by adopting digital technologies to influence customers early in the jour-

ney," Vikas Agnihotri, Country Director-Sales, Google India, said in a statement.

The report indicates a 12 per cent growth in transportation (\$50 billion) and 13 per cent growth in lodging (\$21 billion) and consumption, which includes spends on shopping, recreation and food, to grow at 13 per cent (\$65 billion) over the next three years.

"There is a perception amongst consumers that online channels are geared towards premium customers, along with a marked distrust around

payment and pricing terms. It is imperative for businesses to address these concerns in order to effectively tap into the growing base of users," Arpan Sheth, Partner, Bain & Company said.

As more people come online, smartphone penetration improves and use of digital payments goes up, the report predicts that Indian travellers would spend an additional \$24 billion on online travel bookings over the next three years, a growth from 25 per cent in 2018 to 35 per cent in 2021.
