An anti-terrorism court in Pakistan has rejected the bail application of Bushra Bibi, the wife of jailed former PM Imran Khan, in 12 cases related to the May 9 violence of last year which erupted when Khan was arrested in an alleged corruption case The judge also ordered that the investigation in her case should be completed in seven days. Khan and Bushra were present in the court along with others suspects in the May 9 violence that left more than 100 people dead.
