Putin hails 'sincere' U ahead of Alaska meet

sian President Vladimir Putin on Thursday praised "sincere efforts" by the US to end the war in Ukraine and floated the prospect of a nu-clear arms deal ahead of a summit with President Donald

Trump.
The US was "making, in my The US was "making, in my opinion, quite energetic and sincere efforts to stop the hostilities, stop the crisis and reach agreements that are of interest to all parties involved in this conflict," Putin told his most senior ministers and security officials as he prepared for the meeting with Trump in

Anchorage, Alaska on Friday.

This was happening, Putin said, "in order to create long-term conditions for peace between our countries, and in Europe, and in the world as a whole - if, by the next stages, we reach agreements in the area of control over strategic offensive weapons."

It came a day after Trump warned Russia of "severe con-sequences" if Putin does not sequences" if Putin does not agree to halt his war on Ukraine. "There's a very good chance that we're going to have a second meeting, which will be more productive than the first," Trump said.

Pak officials feted for India conflict role

On the occasion of its Independence Day, Pakistan on Thursday awarded dozens of civilian and military officials, including civilian and military officials, including ministers and services chiefs, for their role in the four-day conflict with India. Army chief Asim Munir was awarded Hilale-Jurat, while Nishan-e-Imtiaz was conferred upon Chairman Joint Chiefs of Staff Committee Gen Sahir Shamshad Mirza. The other awardees included Air chief Zaheer Ahmad Babar Sidhu, Naval chief Admiral Naveed Ashraf, deputy PM Ishaq Dar, Deficee Minister Khawaja Asif and fightre pilots of Pakistan for their role during the aerial combat. aerial combat. Members of the Prime Minister's

Members of the Prime Minister's diplomatic mission were also awarded HilaleImtiaz. As per the army, 488 personnel from the Pakistan Army, Pakistan Air Force and Pakistan Navy were awarded. It said that eight Sitarai-Jurat, five Tamghai-Jurat, 24 Sitarai-Basalat, 45 Tamghai-Basalat, 146 Imtiazi Asnad, 259 COAS Commendation Cards and one Tamghai-Imtiaz (Military) were conferred. The government also conferred Sitarai-Basalat on the ISI chief Lt Gen Muhammad Asim Malik, who is also the National Security Advisor, and on Lt Gen Ahmed Sharif Chaudhry, the army spokesperson.

ANTI-TERROR LAW GETS STRICTER

Pakistan has amended its antiterrorism law to augment the powers of security agencies and the armed forces to detain "suspi-cious" individuals for up to three

months.

The National Assembly on Wednesday passed an amendment to the Anti-Terrorism Act (ATA), 1997, to change Section 11 EEEE (preventive detention for inquiry)

This power was initially pro-vided by an amendment in 2014 to conduct preventive detention of individuals suspected of involvement in terrorism-related activities, but the amendment was subject to a sunset clause and

expired after two years in 2016 In Nov 2024, the government quietly introduced the bill in the National Assembly when Minister of State for Interior and Narcotics Control Tallal Chaudhry moved it, seeking to grant military and civil armed forces the authority to keep individuals facing terror-ism charges in 'preventive' deten-tion for up to three months.

Kuwait's health ministry said 63 people had suffered methanol poisoning from contaminated alcoholic drinks in the five days to Wednesday, resulting in 13 deaths and 21 cases of blindness or impaired vi-

The ministry said in a The ministry said in a statement on X late on Wednesday that all those affected were of Asian nationalities, adding that 51 required urgent kidney dialysis and 31 needed mechanical ventilation.

alcoholic beverages, but some is manufactured in the country illegally in se-cret locations that lack any oversight or safety stan dards, exposing consumers to the risk of poisoning.

The Embassy of India in Kuwait, which has the largest expatriate community in the country, said around 40 Indian nationals in Kuwait have been hospitalized in the last few days, without specifying the cause.
"There have been some

fatalities, some are in a critical condition while others are recovering," it added in a statement on X, noting that it is seeking further details.
