III. The objects for which the Company is established are as under :

A. THE MAIN OBJECTS OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:

1. To carry on the business of manufacturers, producers, fabricators, assemblers, designers, processors, converters, drawer's, electroplaters, repairers, jobbers, contractors, importers, exporters, buyers, sellers, stockists, suppliers, and dealers of Kerosine Wick Stoves, Gas stoves, Gas Tanks & Cylinders, Steel Furniture, Hospital Furnitures and, equipments including Surgical Instruments, Agriculture Equipments air conditioners, coolers, refrigerators, washing machines, water heaters, cooking ranges, gysers, fans, exhaust fans, mixers, electric grinders, juicers, tonsters, room heaters, micro ovens, non stick kitchen wares, and other types of domestic appliances and products which can be conveniently carried on in connection therewith.
2. To carry on the business of manufacturers, producers, fabricators, convertors, jobbers, rollers, smellers, contractors, consulting engineers, dealers, concessionaries of all types of coated plated including zinc, alumintum, zinc aluminium alloys, tin, plastic, vinyl, colour coated/plated and uncoated sheets/strips, coils of all grades of carbon steel, electriqilsteel, grain oriented and non grain oriented ,hot rolled or cold rolled and in corrugated shapes and all kinds of Iron & steel products Including stainless stell products, ingots, billets, blooms, sheets, strips, rounds, bars, plats, pipes, tubes, wieres, rails, slabs, for steel, deams, joists, channels, angles, rools, pig iron and tin products, hardware products, tools and implements and machine parts.

**B. OBJECTS INCIDENTAL ORANCILLARYTO THE ATTAINMENT OF THE MAIN
OBJECTS OF THE COMPANY ARE :**

1. To purchase, hire or otherwise acquire and takeover such existing industrial unit, land, building, plant & machinery, and other accessories as may, from time to time, be required for carrying on all or any of the business of the Company and to buy, sell, trader in, manufacture repairs, convert, alter, let on hire, and deal in goods, machinery implements, rolling, stocks, and hardware Of all kinds and all other articles or things which may be required for the purpose of all or any of the said business or commonly supplied or dealt in by persons engaged in any such business or which may seem capable of being profitable dealt within connection with any of the said business.
2. To secure agencies of Indian and Foreign manufauctueres of allied/anciliary products and to establish agencies or branches for purchase and sale of such products and article in India elsewhere.
3. To enter into any partnership or any arrangement for sharing profits, union of interest, joint adventure, reciprocal concession or otherwise with any individual, firm or Company carrying on or engaged in or about to carry on or engage in any business or enterprise which the company is authorised to carry on or engage in any business or transaction capable of being conducted so as directly or indirectly to benefit this Company and or take of otherwise acquire and hold shares or stock in or securities of and to subsidise or otherwise assist any such Company and to sell, hold, reissue, with or without guarantee or otherwise deal with the same.
5. To enter into any arrangement with any Government or authorities supreme, municipal, local or otherwise that may seem conclusive to the Company's objects or any of them and to obtain from any such Government or authority, any right, privileges and concessions which the Company may think fit desirable to obtain and carry out exerciseand comply with any such arrangements, rights, privileges and concessions.
6. From time to time subscribe render services to any charitable, benevolent or useful object of a public character including exhibition the support of which will in the opinion of the Company tend to increase its repute or popularity among its employees, its customers of the public, to give ,pension, gratuities or charitable aid to person or persons who have served the Company or to the wives, children or other relatives of such persons and to form and contribute to Provident and benefit funds for the benefit of any person engaged by the Company.

7. To dispose or mortgage, exchange; lease or transfer the business property and undertaking of the company or any. part thereof for any lawful consideration which the Company may deem fit to accept and particular buy shares fully or partly paid up, debentures, debenture stock, bonds or securities of any other Company and/or to promote any Company or companies for the purpose of acquiring all or any ,of the properties rights and liabilities for this Company or any other purposes which may seem directly or indirectly calculated to benefit this Company.
8. Generally to purchase, or take on lease or exchange, hire or otherwise acquire any real and personal property and right and privileges, which Company may think necessary or convenient for the purpose of its business and in particular purchase any land, building construction, basement's machinery, plant stock in trade.
9. To invest surplus money of any which the Company not required immediately in any form of investment including shares, stocks, bonds, debentures, obligations or other securities of any Company or association or in Government securities or in deposit with Bank or Banks as may be considered desirable and from time to time to vary such investment.
10. Subject to the provisions of the Company Act, 1956 to lend money to such persons and on such terms and conditions as may seem expedient with or without security and in particular to customers and others having dealings with the Company and to give any guarantee or indemnity as may seem expedient. But the Company will not do banking business as defined under the Banking Regulations Act, 1949.
11. Subject to the provisions of Section 58 A and other relevant sections of the Companies Act, 1956 and rules made thereunder and Directives of Reserve Bank of India to receive money on deposit with or without allowances of interest, to borrow or raise money with or without security and/or secure the payment of money by mortgage or by the issue of bond mortgages, hypothecation, lien or any other security founded or based or charged upon all or any of the property or rights of the Company or in such other manner as the Company shall think fit and for the purposes aforesaid to charge all or any of the Company's property or assets moveables or immovable liquid or otherwise present and future, including its uncalled capital and collaterally or further to secure any securities of the Company by a trust deed or other assurance and to redeem, purchase or pay off any such security. provided that the Company shall not do banking business as defined in the Banking Regulations Act, 1949.
12. To open account with any banks and/or financial institutions and to draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, hundies, bills of lending warrants, debentures and other negotiable instrument subject to Reserve Bank of India's Directives.
13.
